SECTION 4: First aid measures

4.1. Description of first aid measures

SECTION 5: Firefighting measures

5.1. Extinguishing media

Fire hazard : Thermal decomposition generates: Carbon oxides. Hydrogen fluoride.

6.1. Personal precautions, protective equipment and emergency procedures

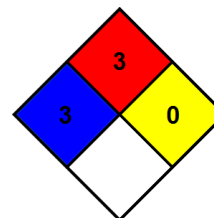
