4.1. Description of first aid measures

5.1. Suitable (and unsuitable) extinguishing media

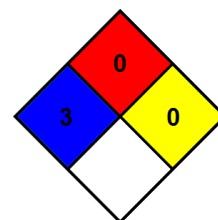
