IN CASE OF CONTACT, IMMEDIATELY FLUSH EYES WITH COPIOUS AMOUNTS OF WATER FOR AT LEAST 15 MINUTES.

#### FLASH POINT

#### **EXTINGUISHING MEDIA**

## PERSONAL PROTECTION

#### **ENVIRONMENTAL PROTECTION**

PREVENT FURTHER LEAKAGE OR SPILLAGE IF SAFE TO DO SO. TAKE PRECAUTIONS TO ENSURE PRODUCT DOES NOT CONTAMINATE THE GROUND OR ENTER THE DRAINAGE SYSTEM.

## **COLLECTION**

CONTAIN SPILLAGE, AND THEN COLLECT WITH AN ELECTRICALLY PROTECTED VACUUM CLEANER OR BY WET-BRUSHING AND PLACE IN CONTAINER FOR DISPOSAL ACCORDING TO LOCAL REGULATIONS.

#### SECTION 7. ----- HANDLING AND STORAGE-----

#### **HANDLING**

USER EXPOSURE: AVOID INHALATION. AVOID CONTACT WITH EYES, SKIN, AND CLOTHING. AVOID PROLONGED OR REPEATED EXPOSURE.
USE EXPLOSION-PROOF EQUIPMENT. KEEP AWAY FROM SOURCES OF IGNITION. TAKE MEASURES TO PREVENT THE BUILD UP OF ELECTROSTATIC CHARGE.
STORAGE

SUITABLE: TIGHTLY CLOSED CONTAINERS IN A DRY AND WELL-VENTILATED PLACE. CONTAINERS WHICH ARE OPENED MUST BE CAREFULLY RESEALED AND KEPT UPRIGHT TO PREVENT LEAKAGE. STORE IN COOL, DRY PLACE. LIGHT SENSITIVE. AVOID DIRECT SUNLIGHT. STORE UNDER INERT GAS. RECOMMENDED STORAGE TEMPERATURE: 2 – 8 °C.

#### **ENGINEERING CONTROLS**

SAFETY SHOWER AND EYE BATH. MECHANICAL EXHAUST REQUIRED.
