EYE EXPOSURE

IN CASE OF CONTACT, IMMEDIATELY FLUSH EYES WITH COPIOUS AMOUNTS OF WATER FOR AT LEAST 15 MINUTES.

SECTION 5. ----- FIRE FIGHTING MEASURES -----

EXTINGUISHING MEDIA

SUITABLE: FOR SMALL (INCIPIENT) FIRES, USE MEDIA SUCH AS "ALCOHOL" FOAM, DRY CHEMICAL, OR CARBON DIOXIDE. FOR LARGE FIRES, APPLY WATER FROM AS FAR AS POSSIBLE. USE VERY LARGE QUANTITIES (FLOODING) OF WATER APPLIED AS A MIST OR SPRAY; SOLID STREAMS OF WATER MAY BE INEFFECTIVE. COOL ALL AFFECTED CONTAINERS WITH FLOODING QUANTITIES OF WATER. FIREFIGHTING

PROTECTIVE EQUIPMENT: WEAR SELF-CONTAINED BREATHING APPARATUS AND PROTECTIVE CLOTHING TO PREVENT CONTACT WITH SKIN AND EYES. SPECIFIC HAZARD(S): FLAMMABLE LIQUID. EMITS TOXIC FUMES UNDER FIRE CONDITIONS.

METHODS FOR CLEANING UP

COVER WITH INERT MATERIAL AND SWEEP UP EXERCISING CAUTION TO NOT RAISE DUST AND PLACE IN COVERED CONTAINERS USING NON-SPARKING TOOLS AND TRANSPORT OUTDOORS. VENTILATE AREA AND WASH SPILL SITE AFTER MATERIAL PICKUP IS COMPLETE.

HANDLING

USER EXPOSURE: AVOID BREATHING VAPORS. AVOID CONTACT WITH EYES, SKIN, AND CLOTHING. AVOID PROLONGED OR REPEATED EXPOSURE. STORAGE

SUITABLE: KEEP CONTAINER CLOSED. KEEP AWAY FROM HEAT, SPARKS, AND OPEN FLAME.
