SECTION 4: First aid measures

4.1. Description of first aid measures

SECTION 6: Accidental release measures

6.1. Personal precautions, protective equipment and emergency procedures

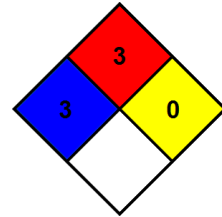
