EXTINGUISHING MEDIA

SUITABLE: FOR SMALL (INCIPIENT) FIRES, USE MEDIA SUCH AS "ALCOHOL" FOAM, DRY CHEMICAL, OR CARBON DIOXIDE. FOR LARGE FIRES, APPLY WATER FROM AS FAR AS POSSIBLE. METHODS FOR CLEANING UP

SWEEP UP OR ABSORB ON DRY SAND OR VERMICULITE, SWEEP UP MATERIAL AND DISPOSE OF AS HAZARDOUS WASTE. PLACE IN CONTAINER FOR DISPOSAL ACCORDING TO LOCAL REGULATIONS.

HANDLING

USER EXPOSURE: AVOID CONTACT WITH SKIN, CLOTHING AND EYES. AVOID FORMATION OF DUST AND AEROSOLS. PROVIDE APPROPRIATE EXHAUST VENTILATION AT PLACES WHERE DUST IS FORMED. NORMAL MEASURES FOR PREVENTIVE FIRE PROTECTION.

STORAGE

SUITABLE: KEEP CONTAINER TIGHTLY CLOSED. STORE IN A COOL DRY PLACE. AIR SENSITIVE. STORE UNDER INERT GAS. LIGHT SENSITIVE. AVOID DIRECT SUNLIGHT. RECOMMENDED STORAGE TEMPERATURE: 2 - 8 °C.

ENGINEERING CONTROLS

SAFETY SHOWER AND EYE BATH. MECHANICAL EXHAUST REQUIRED.

PERSONAL PROTECTIVE EQUIPMENT
