# SECTION 7. ----- HANDLING AND STORAGE-----

## HANDLING

AVOID CONTACT WITH SKIN AND EYES. AVOID INHALATION OF VAPOR, GAS, OR MIST. KEEP AWAY FROM SOURCES IF IGNITION. TAKE MEASURES TO PREVENT THE BUILTUP OF ELECTROSTATIC CHARGE.

#### **STORAGE**

KEEP CONTAINER TIGHTLY CLOSED IN A DRY AND WELL-VENTILATED PLACE. CONTAINERS WHICH ARE OPENED MUST BE CAREFULLY RESEALEDAND KEPT UPRIGHT TO PREVENT LEAKAGE.

STORE UNDER INERT GAS. AIR AND LIGHT SENSITIVE.

#### RESPIRATORY PROTECTION

WHERE RISK ASSESSMENT SHOWS AIR-PURIFYING RESPIRATORS ARE APPROPRIATE USE A FULL-FACE RESPIRATOR WITH MULTIPURPOSE COMBINATION (US) OR TYPE ABEK (EN 14387) RESPIRATOR CARTRIDGES AS A BACKUP TO ENGINEERING CONTROLS.
