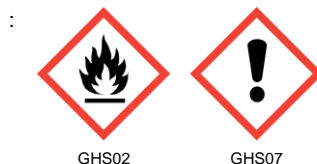

## SECTION 4: First aid measures

### 4.1. Description of first aid measures

#### 6.1. Personal precautions, protective equipment and emergency procedures

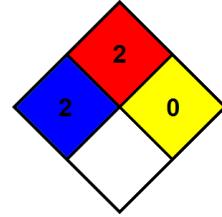
