SECTION 4: First aid measures

4.1. Description of first aid measures

Suitable extinguishing media : Dry powder. Use extinguishing media appropriate for surrounding fire.

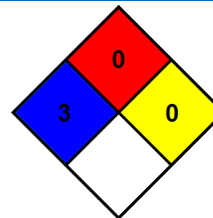
