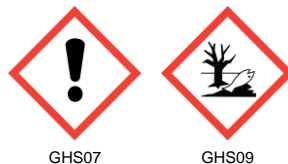

## SECTION 4: First aid measures

### 4.1. Description of first aid measures

## SECTION 5: Firefighting measures

### 5.1. Extinguishing media

### SECTION 6: Accidental release measures

#### 6.1. Personal precautions, protective equipment and emergency procedures

General measures : Evacuate unnecessary personnel. Ensure adequate air ventilation. Do not breathe dust. Do not breathe the gas, fumes, vapor or spray.

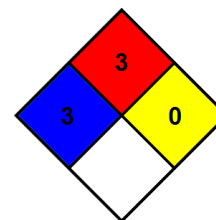
