ORAL EXPOSURE

INHALATION EXPOSURE

IF INHALED, REMOVE TO FRESH AIR. IF NOT BREATHING GIVE ARTIFICIAL RESPIRATION. IF BREATHING IS DIFFICULT, GIVE OXYGEN. DERMAL EXPOSURE

IN CASE OF SKIN CONTACT, FLUSH WITH COPIOUS AMOUNTS OF WATER FOR AT LEAST 15 MINUTES. REMOVE CONTAMINATED CLOTHING AND SHOES. CALL A PHYSICIAN.

EYE EXPOSURE

IN CASE OF CONTACT WITH EYES, FLUSH WITH COPIOUS AMOUNTS OF WATER FOR AT LEAST 15 MINUTES. ASSURE ADEQUATE FLUSHING BY SEPARATING THE EYELIDS WITH FINGERS. CALL A PHYSICIAN.

EXTINGUISHING MEDIA

SUITABLE: FOR SMALL (INCIPIENT) FIRES, USE MEDIA SUCH AS "ALCOHOL" FOAM, DRY CHEMICAL, OR CARBON DIOXIDE. FOR LARGE FIRES, APPLY WATER FROM AS FAR AS POSSIBLE. USE VERY LARGE QUANTITIES (FLOODING) OF WATER APPLIED AS A MIST OR SPRAY; SOLID STREAMS OF WATER MAY BE INEFFECTIVE. COOL ALL AFFECTED CONTAINERS WITH FLOODING QUANTITIES OF WATER.

HANDLING

USER EXPOSURE: DO NOT BREATHE DUST. DO NOT GET IN EYES, ON SKIN, ON CLOTHING. AVOID PROLONGED OR REPEATED EXPOSURE. STORAGE

SUITABLE: KEEP TIGHTLY CLOSED. KEEP AWAY FROM HEAT AND OPEN FLAME. STORE IN A COOL DRY PLACE.

ENGINEERING CONTROLS

SAFETY SHOWER AND EYE BATH. USE ONLY IN A CHEMICAL FUME HOOD. PERSONAL PROTECTIVE EQUIPMENT

RESPIRATORY: USE RESPIRATORS AND COMPONENTS TESTED AND APPROVED UNDER APPROPRIATE GOVERNMENT STANDARDS SUCH AS NIOSH (US) OR CEN (EU). WHERE RISK ASSESSMENT SHOWS AIR-PURIFYING RESPIRATORS ARE APPROPRIATE USE A FULL-FACE RESPIRATOR WITH MULTI-PURPOSE COMBINATION (US) OR TYPE ABEK (EN 14387) RESPIRATOR CARTRIDGES AS A BACKUP TO ENGINEERING CONTROLS. SIGNS AND SYMPTOMS OF EXPOSURE

MATERIAL IS EXTREMELY DESTRUCTIVE TO TISSUE OF THE MUCOUS MEMBRANES AND UPPER RESPIRATORY TRACT, EYES, AND SKIN. INHALATION MAY RESULT IN SPASM, INFLAMMATION AND EDEMA OF THE LARYNX AND BRONCHI, CHEMICAL PNEUMONITIS, AND PULMONARY EDEMA. SYMPTOMS OF EXPOSURE MAY INCLUDE BURNING SENSATION, COUGHING, WHEEZING, LARYNGITIS, SHORTNESS OF BREATH, HEADACHE, NAUSEA, AND VOMITING.
