SUITABLE: WATER SPRAY, ALCOHOL RESISTANT FOAM, DRY CHEMICAL, OR CARBON DIOXIDE. COOL ALL AFFECTED CONTAINERS WITH FLOODING QUANTITIES OF WATER.

FIREFIGHTING

HANDLING

USER EXPOSURE: AVOID INHALATION. AVOID CONTACT WITH EYES, SKIN, AND CLOTHING. AVOID PROLONGED OR REPEATED EXPOSURE.

STORAGE

SUITABLE: TIGHTLY CLOSED CONTAINERS IN A DRY AND WELL-VENTILATED PLACE. CONTAINERS WHICH ARE OPENED MUST BE CAREFULLY RESEALED AND KEPT UPRIGHT TO PREVENT LEAKAGE. STORE IN COOL PLACE. AVOID DIRECT SUNLIGHT. STORE UNDER INERT GAS. RECOMMENDED STORAGE TEMPERATURE: 2 - 8 °C.

RESPIRATORY: USE A FULL-FACE RESPIRATOR WITH MULTI-PURPOSE COMBINATION (US) OR TYPE ABEK (EN 14387) RESPIRATOR CARTRIDGES AS A BACKUP TO ENGINEERING CONTROLS. IF THE RESPIRATOR IS THE SOLE MEANS OF PROTECTION, USE A FULL-FACE SUPPLIED AIR RESPIRATOR. USE RESPIRATORS AND COMPONENTS TESTED AND APPROVED UNDER APPROPRIATE GOVERNMENT STANDARDS SUCH AS NIOSH (US) OR CEN (EU).

HAND: PROTECTIVE GLOVES. GLOVES MUST BE INSPECTED PRIOR TO USE.
