DERMAL EXPOSURE

IN CASE OF CONTACT, WASH SKIN IMMEDIATELY WITH SOAP AND COPIOUS AMOUNTS OF WATER. CONSULT A PHYSICIAN.

SECTION 7. ----- HANDLING AND STORAGE-----

HANDLING

USER EXPOSURE: AVOID CONTACT WITH EYES, SKIN, AND CLOTHING. AVOID FORMATION OF DUST AND AEROSOLS. PROVIDE APPROPRIATE EXHAUST VENTILATION AT PLACES WHERE DUST IS FORMED. NORMAL MEASURES FOR PREVENTIVE FIRE PROTECTION. STORAGE

SUITABLE: KEEP TIGHTLY CLOSED. KEEP AWAY FROM HEAT, SPARKS, AND OPEN FLAME. STORE IN A COOL DRY PLACE. STORE UNDER INER GAS. LIGHT SENSITIVE. AVOID DIRECT SUNLIGHT. RECOMMENDED STORAGE TEMPERATURE: 2 – 8 °C.

ENGINEERING CONTROLS

PERSONAL PROTECTIVE EQUIPMENT

RESPIRATORY: WHERE RISK ASSESSMENT SHOWS AIR-PURIFYING RESPIRATORS ARE APPROPRIATE USE A DUST MASK TYPE N95 (US) OR TYPE P1 (EN 143) RESPIRATOR.
