## SECTION 4: First aid measures

### 4.1. Description of first aid measures

- Fire hazard : Thermal decomposition generates: Carbon oxides. Hydrogen bromide.
- Explosion hazard : Risk of explosion if heated under confinement. Use water spray or fog for cooling exposed containers.

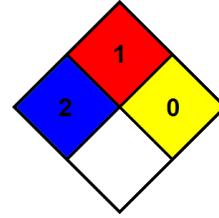
