## SECTION 4. ----- FIRST-AID MEASURES-----

DERMAL EXPOSURE

IN CASE OF CONTACT, IMMEDIATELY WASH SKIN WITH SOAP AND COPIOUS AMOUNTS OF WATER.

EYE EXPOSURE

IN CASE OF CONTACT, IMMEDIATELY FLUSH EYES WITH COPIOUS AMOUNTS OF WATER FOR AT LEAST 15 MINUTES.

#### **EXTINGUISHING MEDIA**

SUITABLE: FOR SMALL (INCIPIENT) FIRES, USE MEDIA SUCH AS "ALCOHOL" FOAM, DRY CHEMICAL, OR CARBON DIOXIDE. FOR LARGE FIRES, APPLY WATER FROM AS FAR AS POSSIBLE. # SECTION 6. ----- ACCIDENTAL RELEASE MEASURES-----

## PERSONAL PROTECTION

AVOID BREATHING VAPOR MIST, OR GAS. ENSURE ADEQYATE VENTILATION. WEAR PROTECTIVE EQUIPMENT INCLUDING RUBBER GLOVES, AND EYE PROTECTION. KEEP UNPROTECTED PERSONS AWAY.

#### ENVIRONMENTAL PROTECTION

## COLLECTION

CONTAIN SPILLAGE, AND THEN COLLECT WITH AN ELECTRICALLY PROTECTED VACUUM CLEANER OR BY WET-BRUSHING AND PLACE IN CONTAINER FOR DISPOSAL ACCORDING TO LOCAL REGULATIONS.

# SECTION 7. ----- HANDLING AND STORAGE-----

#### HANDLING

USER EXPOSURE: AVOID INHALATION. AVOID CONTACT WITH EYES, SKIN, AND CLOTHING. AVOID PROLONGED OR REPEATED EXPOSURE. USE EXPLOSION-PROOF EQUIPMENT. KEEP AWAY FROM SOURCES OF IGNITION. TAKE MEASURES TO PREVENT THE BUILD UP OF ELECTROSTATIC CHARGE. STORAGE
