**PERSONAL PROTECTION**

**COLLECTION**

**SECTION 7. ----- HANDLING AND STORAGE-----**

**HANDLING**

USER EXPOSURE: AVOID INHALATION. AVOID CONTACT WITH EYES, SKIN, AND CLOTHING. AVOID PROLONGED OR REPEATED EXPOSURE.

USE EXPLOSION-PROOF EQUIPMENT. KEEP AWAY FROM SOURCES OF IGNITION.

TAKE MEASURES TO PREVENT THE BUILD UP OF ELECTROSTATIC CHARGE.

**STORAGE**

SUITABLE: TIGHTLY CLOSED CONTAINERS IN A DRY AND WELL-VENTILATED PLACE.

CONTAINERS WHICH ARE OPENED MUST BE CAREFULLY RESEALED AND KEPT UPRIGHT TO PREVENT LEAKAGE. STORE IN COOL, DRY PLACE. AIR SENSITIVE. STORE UNDER INERT GAS. AVOID DIRECT SUNLIGHT. RECOMMENDED STORAGE TEMPERATURE: 2 - 8 °C.

### **PERSONAL PROTECTIVE EQUIPMENT**

HAND: PROTECTIVE GLOVES. GLOVES MUST BE INSPECTED PRIOR TO USE.

EYE: CHEMICAL SAFETY GOGGLES.
