**SECTION 7. ----- HANDLING AND STORAGE-----**

**HANDLING**

USER EXPOSURE: AVOID INHALATION. AVOID CONTACT WITH EYES, SKIN, AND CLOTHING. AVOID PROLONGED OR REPEATED EXPOSURE.

**STORAGE**
