HANDLING

USER EXPOSURE: DO NOT BREATHE VAPOR. AVOID CONTACT WITH EYES, SKIN, AND CLOTHING. AVOID PROLONGED OR REPEATED EXPOSURE. STORAGE

ENGINEERING CONTROLS
