DERMAL EXPOSURE

IN CASE OF CONTACT, WASH SKIN IMMEDIATELY WITH SOAP AND COPIOUS AMOUNTS OF WATER. CONSULT A PHYSICIAN.

EXTINGUISHING MEDIA

SUITABLE: FOR SMALL (INCIPIENT) FIRES, USE MEDIA SUCH AS

FIRES, APPLY WATER FROM AS FAR AS POSSIBLE. USE VERY LARGE

FIREFIGHTING

SECTION 7. ----- HANDLING AND STORAGE-----

HANDLING

USER EXPOSURE: AVOID CONTACT WITH EYES, SKIN, AND CLOTHING. AVOID FORMATION OF DUST AND AEROSOLS. PROVIDE APPROPRIATE EXHAUST VENTILATION AT PLACES WHERE DUST IS FORMED. NORMAL MEASURES FOR PREVENTIVE FIRE PROTECTION. STORAGE

SUITABLE: KEEP TIGHTLY CLOSED. KEEP AWAY FROM HEAT, SPARKS, AND OPEN FLAME. STORE IN A COOL DRY PLACE. STORE UNDER NITROGEN. LIGHT SENSITIVE. AVOID DIRECT SUNLIGHT.

ENGINEERING CONTROLS

SAFETY SHOWER AND EYE BATH. MECHANICAL EXHAUST REQUIRED.

PERSONAL PROTECTIVE EQUIPMENT

RESPIRATORY: WHERE RISK ASSESSMENT SHOWS AIR-PURIFYING RESPIRATORS ARE APPROPRIATE USE A DUST MASK TYPE N95 (US) OR TYPE P1 (EN 143) RESPIRATOR. USE RESPIRATORS AND COMPONENTS TESTED AND APPROVED UNDER APPROPRIATE
