EXTINGUISHING MEDIA

SUITABLE: FOR SMALL (INCIPIENT) FIRES, USE MEDIA SUCH AS

FIRES, APPLY WATER FROM AS FAR AS POSSIBLE. USE VERY LARGE

FIREFIGHTING

HANDLING

ENGINEERING CONTROLS
