### **FLASH POINT**

### **EXTINGUISHING MEDIA**

SUITABLE: FOR SMALL (INCIPIENT) FIRES, USE MEDIA SUCH AS "ALCOHOL" FOAM, DRY CHEMICAL, OR CARBON DIOXIDE. FOR LARGE FIRES, APPLY WATER FROM AS FAR AS POSSIBLE. ### **HANDLING**

### **ENGINEERING CONTROLS**

SAFETY SHOWER AND EYE BATH. MECHANICAL EXHAUST REQUIRED.
