**EXTINGUISHING MEDIA**

**PERSONAL PROTECTION**

**COLLECTION**

**SECTION 7. ----- HANDLING AND STORAGE-----**

**HANDLING**

USER EXPOSURE: AVOID INHALATION. AVOID CONTACT WITH EYES, SKIN, AND CLOTHING. AVOID PROLONGED OR REPEATED EXPOSURE.

USE EXPLOSION-PROOF EQUIPMENT. KEEP AWAY FROM SOURCES OF IGNITION.

**STORAGE**

SUITABLE: TIGHTLY CLOSED CONTAINERS IN A DRY AND WELL-VENTILATED PLACE.

CONTAINERS WHICH ARE OPENED MUST BE CAREFULLY RESEALED AND KEPT

UPRIGHT TO PREVENT LEAKAGE. STORE IN COOL, DRY PLACE. STORE UNDER INERT GAS.

### **PERSONAL PROTECTIVE EQUIPMENT**

RESPIRATORY: USE A FULL-FACE RESPIRATOR WITH MULTI-PURPOSE COMBINATION (US) OR TYPE ABEK (EN 14387) RESPIRATOR CARTRIDGES AS A BACKUP TO ENGINEERING CONTROLS. HAND: PROTECTIVE GLOVES. GLOVES MUST BE INSPECTED PRIOR TO USE.
