SECTION 4: First aid measures

4.1. Description of first aid measures

First-aid measures general : In case of accident or if you feel unwell, seek medical advice immediately (show the label where possible). Move the affected personnel away from the contaminated area.

SECTION 5: Firefighting measures

5.1. Extinguishing media

Suitable extinguishing media : Alcohol resistant foam. Carbon dioxide. Dry powder. Water spray. Use extinguishing media appropriate for surrounding fire.

5.2. Special hazards arising from the substance or mixture

Fire hazard : Thermal decomposition generates: Carbon oxides. Hydrogen chloride. Hydrogen fluoride. Nitrogen oxides.

Explosion hazard : When mixed with air and exposed to an ignition source, dust may burn in the open air or explode if confined. Risk of explosion if heated under confinement. Use water spray or fog for cooling exposed containers. May form flammable/explosive vapor-air mixture.

5.3. Advice for firefighters

Firefighting instructions : In case of fire: Evacuate area. Fight fire remotely due to the risk of explosion.

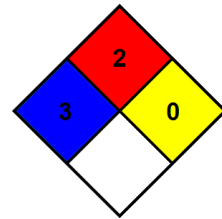
