EXTINGUISHING MEDIA

SUITABLE: FOR SMALL (INCIPIENT) FIRES, USE MEDIA SUCH AS "ALCOHOL" FOAM, DRY CHEMICAL, OR CARBON DIOXIDE. FOR LARGE FIRES, APPLY WATER FROM AS FAR AS POSSIBLE. USE VERY LARGE QUANTITIES (FLOODING) OF WATER APPLIED AS A MIST OR SPRAY; SOLID

FIREFIGHTING

PROTECTIVE EQUIPMENT: WEAR SELF-CONTAINED BREATHING APPARATUS AND PROTECTIVE CLOTHING TO PREVENT CONTACT WITH SKIN AND EYES. SPECIFIC METHOD(S) OF FIRE FIGHTING: USE WATER SPRAY TO COOL FIRE-EXPOSED CONTAINERS.

HANDLING

USER EXPOSURE: AVOID CONTACT WITH SKIN, CLOTHING AND EYES. AVOID FORMATION OF DUST AND AEROSOLS. PROVIDE APPROPRIATE EXHAUST VENTILATION AT PLACES WHERE DUST IS FORMED. NORMAL MEASURES FOR PREVENTIVE FIRE PROTECTION. STORAGE

SUITABLE: KEEP CONTAINER TIGHTLY CLOSED. STORE IN A COOL DRY PLACE. STORE UNDER INERT GAS. LIGHT SENSITIVE. AVOID DIRECT SUNLIGHT.

ENGINEERING CONTROLS

PERSONAL PROTECTIVE EQUIPMENT

APPROPRIATE USE A DUST MASK TYPE N95 (US) OR TYPE P1 (EN 143) RESPIRATOR.
