EXTINGUISHING MEDIA

SUITABLE: FOR SMALL (INCIPIENT) FIRES, USE MEDIA SUCH AS

FIRES, APPLY WATER FROM AS FAR AS POSSIBLE. USE VERY LARGE

FIREFIGHTING

HANDLING

USER EXPOSURE: AVOID CONTACT WITH SKIN, CLOTHING AND EYES. AVOID FORMATION OF DUST AND AEROSOLS. PROVIDE APPROPRIATE EXHAUST VENTILATION AT PLACES WHERE DUST IS FORMED. NORMAL MEASURES FOR PREVENTIVE FIRE PROTECTION. STORAGE

SUITABLE: KEEP TIGHTLY CLOSED. NORMAL MEASURES FOR PREVENTIVE FIRE PROTECTION.

STORE IN A COOL DRY PLACE. STORE UNDER NITROGEN. AVOID DIRECT SUNLIGHT AND MOISTURE. RECOMMENDED STORAGE TEMPERATURE: 2 – 8 °C.
