EXTINGUISHING MEDIA

SUITABLE: FOR SMALL (INCIPIENT) FIRES, USE MEDIA SUCH AS

FIRES, APPLY WATER FROM AS FAR AS POSSIBLE. USE VERY LARGE

FIREFIGHTING

HANDLING

SUITABLE: KEEP CONTAINER TIGHTLY CLOSED. STORE IN A COOL DRY PLACE. AVOID DIRECT SUNLIGHT. STORE UNDER INERT GAS. RECOMMENDED STORAGE TEMPERATURE: 2 – 8 °C.
