#### **EXTINGUISHING MEDIA**

## **HANDLING**

SUITABLE: KEEP CONTAINER TIGHTLY CLOSED. STORE IN A COOL DRY PLACE. AIR SENSITIVE. STORE UNDER INERT GAS. LIGHT SENSITIVE. AVOID DIRECT SUNLIGHT. RECOMMENDED STORAGE TEMPERATURE: 2 – 8 °C.
