SUITABLE: WATER SPRAY, ALCOHOL RESISTANT FOAM, DRY CHEMICAL, OR CARBON DIOXIDE.

COOL ALL AFFECTED CONTAINERS WITH FLOODING QUANTITIES OF WATER.

FIREFIGHTING

PROTECTIVE EQUIPMENT: WEAR SELF-CONTAINED BREATHING APPARATUS AND PROTECTIVE CLOTHING TO PREVENT CONTACT WITH SKIN AND EYES.

HANDLING

USER EXPOSURE: AVOID CONTACT WITH SKIN AND EYES. AVOID FORMATION OF DUST AND AEROSOLS. PROVIDE APPROPRIATE EXHAUST VENTILATION AT PLACES WHERE DUST IS FORMED. NORMAL MEASURES FOR PREVENTIVE FIRE PROTECTION. AVOID CONTACT WITH EYES, SKIN, AND CLOTHING.

STORAGE

SUITABLE: KEEP TIGHTLY CLOSED. KEEP AWAY FROM HEAT, SPARKS, AND OPEN FLAME. STORE IN A COOL DRY PLACE. AVOID DIRECT SUNLIGHT. AVOID MOISTURE.

ENGINEERING CONTROLS

SAFETY SHOWER AND EYE BATH. MECHANICAL EXHAUST REQUIRED.

PERSONAL PROTECTIVE EQUIPMENT

RESPIRATORY: USE RESPIRATORS AND COMPONENTS TESTED AND APPROVED APPROPRIATE GOVERNMENT STANDARDS SUCH AS NIOSH (US) OR CEN (EU). WHERE RISK ASSESSMENT SHOWS AIR-PURIFYING RESPIRATORS ARE APPROPRIATE USE A FULL-FACE RESPIRATOR WITH MULTI-PURPOSE COMBINATION (US) OR TYPE ABEK (EN 14387) RESPIRATOR CARTRIDGES AS A BACKUP TO ENGINEERING CONTROLS.
