FLASH POINT

EXTINGUISHING MEDIA

SUITABLE: FOR SMALL (INCIPIENT) FIRES, USE MEDIA SUCH AS

"ALCOHOL" FOAM, DRY CHEMICAL, OR CARBON DIOXIDE. FOR LARGE

FIRES, APPLY WATER FROM AS FAR AS POSSIBLE. USE VERY LARGE

QUANTITIES (FLOODING) OF WATER APPLIED AS A MIST OR SPRAY; SOLID

STREAMS OF WATER MAY BE INEFFECTIVE. COOL ALL AFFECTED

CONTAINERS WITH FLOODING QUANTITIES OF WATER.

FIREFIGHTING

PROTECTIVE EQUIPMENT: WEAR SELF-CONTAINED BREATHING APPARATUS AND PROTECTIVE CLOTHING TO PREVENT CONTACT WITH SKIN AND EYES. SPECIFIC METHOD(S) OF FIRE FIGHTING: USE WATER SPRAY TO COOL FIRE-EXPOSED CONTAINERS.

HANDLING

ENGINEERING CONTROLS

PERSONAL PROTECTIVE EQUIPMENT

RESPIRATORY: WHERE RISK ASSESSMENT SHOWS AIR-PURIFYING RESPIRATORS ARE

APPROPRIATE USE A DUST MASK TYPE N95 (US) OR TYPE P1 (EN 143) RESPIRATOR.
