FIREFIGHTING

HANDLING

SUITABLE: KEEP CONTAINER TIGHTLY CLOSED. STORE IN A COOL DRY PLACE. LIGHT SENSITIVE. AVOID DIRECT SUNLIGHT. AIR SENSITIVE. STORE UNDER INERT GAS. RECOMMENDED STORAGE TEMPERATURE: 2 – 8 °C.

ENGINEERING CONTROLS
