ASSURE ADEQUATE FLUSHING OF THE EYES BY SEPARATING THE EYELIDS WITH FINGERS. CALL A POISON CENTER. CONTINUE RINSING EYES DURING TRANSPORT TO HOSPITAL. DERMAL EXPOSURE

IN CASE OF CONTACT, WASH SKIN IMMEDIATELY WITH SOAP AND COPIOUS AMOUNTS OF WATER. CONSULT A PHYSICIAN.
