ORAL EXPOSURE

IF SWALLOWED, WASH OUT MOUTH WITH WATER PROVIDED PERSON IS CONSCIOUS. CALL A PHYSICIAN. DO NOT INDUCE VOMITING.

INHALATION EXPOSURE

IF INHALED, REMOVE TO FRESH AIR. IF NOT BREATHING GIVE ARTIFICIAL RESPIRATION. IF BREATHING IS DIFFICULT, GIVE OXYGEN. DERMAL EXPOSURE

IN CASE OF SKIN CONTACT, FLUSH WITH COPIOUS AMOUNTS OF WATER FOR AT LEAST 15 MINUTES. REMOVE CONTAMINATED CLOTHING AND SHOES. CALL A PHYSICIAN.

EYE EXPOSURE

IN CASE OF CONTACT WITH EYES, FLUSH WITH COPIOUS AMOUNTS OF WATER FOR AT LEAST 15 MINUTES. ASSURE ADEQUATE FLUSHING BY SEPARATING THE EYELIDS WITH FINGERS. CALL A PHYSICIAN.

SUITABLE: CARBON DIOXIDE, DRY CHEMICAL POWDER, OR APPROPRIATE FOAM.

FIREFIGHTING

PROTECTIVE EQUIPMENT: WEAR SELF-CONTAINED BREATHING APPARATUS AND PROTECTIVE CLOTHING TO PREVENT CONTACT WITH SKIN AND EYES. SPECIFIC HAZARD(S): EMITS TOXIC FUMES UNDER FIRE CONDITIONS.

HANDLING

USER EXPOSURE: DO NOT BREATHE DUST. DO NOT GET IN EYES, ON SKIN, ON CLOTHING. AVOID PROLONGED OR REPEATED EXPOSURE. STORAGE

SUITABLE: KEEP TIGHTLY CLOSED. STORE UNDER AN INERT GAS.

SECTION 8. ---- EXPOSURE CONTROLS/PERSONAL PROTECTION-----

ENGINEERING CONTROLS

SAFETY SHOWER AND EYE BATH. USE ONLY IN A CHEMICAL FUME HOOD. PERSONAL PROTECTIVE EQUIPMENT

RESPIRATORY: USE RESPIRATORS AND COMPONENTS TESTED AND APPROVED UNDER APPROPRIATE GOVERNMENT STANDARDS SUCH AS NIOSH (US) OR CEN (EU). WHERE RISK ASSESSMENT SHOWS AIR-PURIFYING RESPIRATORS ARE APPROPRIATE USE A FULL-FACE PARTICLE RESPIRATOR TYPE N100 (US) OR TYPE P3 (EN 143) RESPIRATOR CARTRIDGES AS A BACKUP TO ENGINEERING CONTROLS.
