FLASH POINT

EXTINGUISHING MEDIA

SUITABLE: FOR SMALL (INCIPIENT) FIRES, USE MEDIA SUCH AS "ALCOHOL" FOAM, DRY CHEMICAL, OR CARBON DIOXIDE. FOR LARGE FIRES, APPLY WATER FROM AS FAR AS POSSIBLE. FIREFIGHTING

METHODS FOR CLEANING UP

SWEEP UP OR ABSORB ON DRY SAND OR VERMICULITE, SWEEP UP MATERIAL AND DISPOSE OF AS HAZARDOUS WASTE. PLACE IN CONTAINER FOR DISPOSAL ACCORDING TO LOCAL REGULATIONS.

HANDLING

STORAGE

ENGINEERING CONTROLS
