### **FIREFIGHTING**

# HANDLING

SUITABLE: KEEP CONTAINER TIGHTLY CLOSED. STORE IN A COOL DRY PLACE. STORE UNDER INERT GAS. AVOID DIRECT SUNLIGHT. RECOMMENDED STORAGE TEMPERATURE:  $2-8\,^{\circ}\text{C}$ .
