### **FLASH POINT**

### **EXTINGUISHING MEDIA**

SUITABLE: FOR SMALL (INCIPIENT) FIRES, USE MEDIA SUCH AS "ALCOHOL" FOAM, DRY CHEMICAL, OR CARBON DIOXIDE. FOR LARGE FIRES, APPLY WATER FROM AS FAR AS POSSIBLE. ## **SECTION 7. ----- HANDLING AND STORAGE-----**

### **HANDLING**

### **STORAGE**
