FLASH POINT

EXTINGUISHING MEDIA

PERSONAL PROTECTION

ENVIRONMENTAL PROTECTION

COLLECTION

SECTION 7. ----- HANDLING AND STORAGE-----

HANDLING

USER EXPOSURE: AVOID INHALATION. AVOID CONTACT WITH EYES, SKIN, AND CLOTHING. AVOID PROLONGED OR REPEATED EXPOSURE.
USE EXPLOSION-PROOF EQUIPMENT. KEEP AWAY FROM SOURCES OF IGNITION.

STORAGE

SUITABLE: TIGHTLY CLOSED CONTAINERS IN A DRY AND WELL-VENTILATED PLACE. CONTAINERS WHICH ARE OPENED MUST BE CAREFULLY RESEALED AND KEPT UPRIGHT TO PREVENT LEAKAGE. STORE IN COOL, DRY PLACE. AVOID DIRECT SUNLIGHT. MOISTURE SENSITIVE. STORE UNDER INERT GAS. RECOMMENDED STORAGE TEMPERATURE: -20 °C.
