EXTINGUISHING MEDIA

FIRES, APPLY WATER FROM AS FAR AS POSSIBLE. USE VERY LARGE

FIREFIGHTING

HANDLING

ENGINEERING CONTROLS

PERSONAL PROTECTIVE EQUIPMENT
