### EXTINGUISHING MEDIA

SUITABLE: FOR SMALL (INCIPIENT) FIRES, USE MEDIA SUCH AS "ALCOHOL" FOAM, DRY CHEMICAL, OR CARBON DIOXIDE. FOR LARGE FIRES, APPLY WATER FROM AS FAR AS POSSIBLE. ## **SECTION 6. ----- ACCIDENTAL RELEASE MEASURES-----**

### PERSONAL PROTECTION

WEAR PROTECTIVE EQUIPMENT INCLUDING RUBBER GLOVES, AND EYE PROTECTION.

KEEP UNPROTECTED PERSONS AWAY.

### ENVIRONMENTAL PROTECTION

### COLLECTION

CONTAIN SPILLAGE, AND THEN COLLECT WITH AN ELECTRICALLY PROTECTED VACUUM CLEANER OR BY WET-BRUSHING AND PLACE IN CONTAINER FOR DISPOSAL ACCORDING TO LOCAL REGULATIONS.

## **SECTION 7. ----- HANDLING AND STORAGE-----**

### HANDLING

USER EXPOSURE: AVOID INHALATION. AVOID CONTACT WITH EYES, SKIN, AND CLOTHING. AVOID PROLONGED OR REPEATED EXPOSURE.

USE EXPLOSION-PROOF EQUIPMENT. KEEP AWAY FROM SOURCES OF IGNITION.

### STORAGE

SUITABLE: TIGHTLY CLOSED CONTAINERS IN A DRY AND WELL-VENTILATED PLACE.

UPRIGHT TO PREVENT LEAKAGE. STORE IN COOL, DRY PLACE. MOISTURE SENSITIVE.

STORE UNDER INERT GAS. RECOMMENDED STORAGE TEMPERATURE: 2 - 8 °C.

### **ENGINEERING CONTROLS**

SAFETY SHOWER AND EYE BATH. MECHANICAL EXHAUST REQUIRED.

### **PERSONAL PROTECTIVE EQUIPMENT**

RESPIRATORY: USE A FULL-FACE RESPIRATOR WITH MULTI-PURPOSE COMBINATION (US) OR TYPE ABEK (EN 14387) RESPIRATOR CARTRIDGES AS A BACKUP TO ENGINEERING CONTROLS. HAND: PROTECTIVE GLOVES. GLOVES MUST BE INSPECTED PRIOR TO USE.
