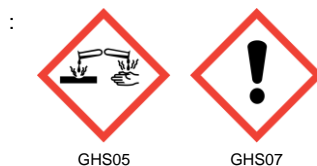

SECTION 4: First aid measures

4.1. Description of first aid measures

First-aid measures general : In case of accident or if you feel unwell, seek medical advice immediately (show the label where possible). Move the affected personnel away from the contaminated area.

4.2. Most important symptoms and effects, both acute and delayed

Symptoms/injuries : The most important known symptoms and effects are described in the labelling (see section 2.2) and/or in section 11.

Symptoms/injuries after inhalation : Material is destructive to tissue of the mucous membranes and upper respiratory tract. Cough, shortness of breath, headache, nausea.

4.3. Indication of any immediate medical attention and special treatment needed

SECTION 5: Firefighting measures

5.1. Extinguishing media

Suitable extinguishing media : Dry powder. Use extinguishing media appropriate for surrounding fire.

Fire hazard : Thermal decomposition generates: Carbon oxides. Hydrogen chloride. Hydrogen fluoride. Silicon oxides.

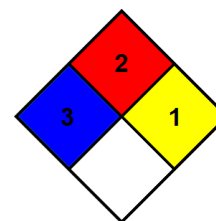
