EXTINGUISHING MEDIA

SUITABLE: FOR SMALL (INCIPIENT) FIRES, USE MEDIA SUCH AS "ALCOHOL" FOAM, DRY CHEMICAL, OR CARBON DIOXIDE. FOR LARGE FIRES, APPLY WATER FROM AS FAR AS POSSIBLE. PERSONAL PROTECTION

AVOID BREATHING VAPOR MIST, OR GAS. ENSURE ADEQYATE VENTILATION. WEAR PROTECTIVE EQUIPMENT INCLUDING RUBBER GLOVES, AND EYE PROTECTION. KEEP UNPROTECTED PERSONS AWAY.

ENVIRONMENTAL PROTECTION

COLLECTION

CONTAIN SPILLAGE, AND THEN COLLECT WITH AN ELECTRICALLY PROTECTED VACUUM CLEANER OR BY WET-BRUSHING AND PLACE IN CONTAINER FOR DISPOSAL ACCORDING TO LOCAL REGULATIONS.

SECTION 7. ----- HANDLING AND STORAGE-----

HANDLING

USER EXPOSURE: AVOID INHALATION. AVOID CONTACT WITH EYES, SKIN, AND CLOTHING. AVOID PROLONGED OR REPEATED EXPOSURE. USE EXPLOSION-PROOF EQUIPMENT. KEEP AWAY FROM SOURCES OF IGNITION.

STORAGE

SUITABLE: TIGHTLY CLOSED CONTAINERS IN A DRY AND WELL-VENTILATED PLACE. CONTAINERS WHICH ARE OPENED MUST BE CAREFULLY RESEALED AND KEPT UPRIGHT TO PREVENT LEAKAGE. STORE IN COOL, DRY PLACE. AIR SENSITIVE. MOISTURE SENSITIVE. STORE UNDER NITROGEN. AVOID DIRECT SUNLIGHT. RECOMMENDED STORAGE TEMPERATURE: 2 - 8 °C.

PERSONAL PROTECTIVE EQUIPMENT

IF THE RESPIRATOR IS THE SOLE MEANS OF PROTECTION, USE A FULL-FACE SUPPLIED AIR RESPIRATOR.
