IN CASE OF CONTACT, WASH SKIN IMMEDIATELY WITH SOAP AND COPIOUS AMOUNTS OF WATER. CONSULT A PHYSICIAN.

EXTINGUISHING MEDIA

SUITABLE: WATER SPRAY, FOAM, DRY CHEMICAL OR CARBON DIOXIDE.

COOL ALL AFFECTED CONTAINERS WITH FLOODING QUANTITIES OF WATER.

FIREFIGHTING

PROTECTIVE EQUIPMENT: WEAR SELF-CONTAINED BREATHING APPARATUS AND PROTECTIVE CLOTHING TO PREVENT CONTACT WITH SKIN AND EYES.

SPECIFIC METHOD(S) OF FIRE FIGHTING: USE WATER SPRAY TO COOL FIRE-EXPOSED CONTAINERS.

HANDLING

USER EXPOSURE: AVOID CONTACT WITH SKIN, EYES AND CLOTHES. AVOID FORMATION OF DUST AND AEROSOLS. PROVIDE APPROPRIATE EXHAUST VENTILATION AT PLACES WHERE DUST IS FORMED. NORMAL MEASURES FOR PREVENTIVE FIRE PROTECTION.

STORAGE

SUITABLE: KEEP TIGHTLY CLOSED. KEEP AWAY FROM HEAT, SPARKS, AND OPEN FLAME. STORE IN A COOL DRY PLACE. AVOID DIRECT SUNLIGHT. STORE UNDER NITROGEN. MOISTURE SENSITIVE.

ENGINEERING CONTROLS

SAFETY SHOWER AND EYE BATH. MECHANICAL EXHAUST REQUIRED.

PERSONAL PROTECTIVE EQUIPMENT
