EXTINGUISHING MEDIA

SUITABLE: FOR SMALL (INCIPIENT) FIRES, USE MEDIA SUCH AS "ALCOHOL" FOAM, DRY CHEMICAL, OR CARBON DIOXIDE. FOR LARGE FIRES, APPLY WATER FROM AS FAR AS POSSIBLE. COLLECTION

CONTAIN SPILLAGE, AND THEN COLLECT WITH AN ELECTRICALLY PROTECTED VACUUM CLEANER OR BY WET-BRUSHING AND PLACE IN CONTAINER FOR DISPOSAL ACCORDING TO LOCAL REGULATIONS.

SECTION 7. ----- HANDLING AND STORAGE-----

HANDLING

USER EXPOSURE: AVOID INHALATION. AVOID CONTACT WITH EYES, SKIN AND CLOTHING. AVOID PROLONGED OR REPEATED EXPOSURE.

USE EXPLOSION-PROOF EQUIPMENT. KEEP AWAY FROM SOURCES OF IGNITION.

STORAGE

SUITABLE: TIGHTLY CLOSED CONTAINERS IN A DRY AND WELL-VENTILATED PLACE.

CONTAINERS WHICH ARE OPENED MUST BE CAREFULLY RESEALED AND KEPT

UPRIGHT TO PREVENT LEAKAGE. STORE IN COOL, DRY PLACE. STORE UNDER INERT GAS.

AVOID DIRECT SUNLIGHT. RECOMMENDED STORAGE TEMPERATURE: 2 - 8 °C.

ENGINEERING CONTROLS

SAFETY SHOWER AND EYE BATH. MECHANICAL EXHAUST REQUIRED.

PERSONAL PROTECTIVE EQUIPMENT

RESPIRATORY: WHERE RISK ASSESSMENT SHOWS AIR-PURIFYING RESPIRATORS ARE APPROPRIATE USE A DUST MASK TYPE N95 (US) OR TYPE P1 (EN 143) RESPIRATOR.
