SECTION 5: Fire-fighting measures

5.1. Suitable (and unsuitable) extinguishing media

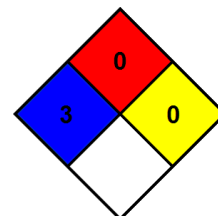
