IN CASE OF CONTACT, WASH SKIN IMMEDIATELY WITH SOAP AND COPIOUS AMOUNTS OF WATER. CONSULT A PHYSICIAN.

EXTINGUISHING MEDIA

HANDLING

STORAGE

ENGINEERING CONTROLS
