HANDLING

CHRONIC CADMIUM EXPOSURE CAN CAUSE NUMEROUS ADVERSE HEALTH EFFECTS INCLUDING EMPHYSEMA AND CANCER. CADMIUM POISONING MAY CAUSE WEAKNESS, CONVULSIONS, AND DEATH.
