HANDLING

USER EXPOSURE: AVOID CONTACT WITH SKIN, CLOTHING AND EYES. AVOID FORMATION OF DUST AND AEROSOLS. PROVIDE APPROPRIATE EXHAUST VENTILATION AT PLACES WHERE DUST IS FORMED. DO NOT STORE NEAR, NOR ALLOW CONTACT WITH CLOTHING AND COMBUSTIBLE MATERIAL. KEEP AWAY FROM SOURCES OF IGNITION.
