EXTINGUISHING MEDIA

HANDLING

USER EXPOSURE: DO NOT BREATHE DUST. AVOID CONTACT WITH EYES, SKIN, AND CLOTHING. AVOID PROLONGED OR REPEATED EXPOSURE. STORAGE

SUITABLE: KEEP TIGHTLY CLOSED. KEEP AWAY FROM HEAT AND OPEN FLAME. STORE IN A COOL DRY PLACE.
