EXTINGUISHING MEDIA

SUITABLE: FOR SMALL (INCIPIENT) FIRES, USE MEDIA SUCH AS

FIRES, APPLY WATER FROM AS FAR AS POSSIBLE. USE VERY LARGE

QUANTITIES (FLOODING) OF WATER APPLIED AS A MIST OR SPRAY; SOLID

FIREFIGHTING

HANDLING
