**SECTION 7. ----- HANDLING AND STORAGE-----**

**HANDLING**

USER EXPOSURE: AVOID INHALATION. AVOID CONTACT WITH EYES, SKIN, AND CLOTHING. AVOID PROLONGED OR REPEATED EXPOSURE.

USE EXPLOSION-PROOF EQUIPMENT. KEEP AWAY FROM SOURCES OF IGNITION.

**STORAGE**

SUITABLE: TIGHTLY CLOSED CONTAINERS IN A DRY AND WELL-VENTILATED PLACE.

CONTAINERS WHICH ARE OPENED MUST BE CAREFULLY RESEALED AND KEPT UPRIGHT TO PREVENT LEAKAGE. STORE IN COOL, DRY PLACE. LIGHT SENSITIVE.

RECOMMENDED STORAGE TEMPERATURE: 2 - 8 °C.

HAND: PROTECTIVE GLOVES. GLOVES MUST BE INSPECTED PRIOR TO USE.
