EXTINGUISHING MEDIA

FIREFIGHTING

PERSONAL PROTECTION

ENVIRONMENTAL PROTECTION

COLLECTION

CONTAIN SPILLAGE, AND THEN COLLECT WITH AN ELECTRICALLY PROTECTED VACUUM CLEANER OR BY WET-BRUSHING AND PLACE IN CONTAINER FOR DISPOSAL ACCORDING TO LOCAL REGULATIONS.

SECTION 7. ----- HANDLING AND STORAGE-----

HANDLING

USER EXPOSURE: AVOID INHALATION. AVOID CONTACT WITH EYES, SKIN, AND CLOTHING. AVOID PROLONGED OR REPEATED EXPOSURE. USE EXPLOSION-PROOF EQUIPMENT. KEEP AWAY FROM SOURCES OF IGNITION.

STORAGE

SUITABLE: TIGHTLY CLOSED CONTAINERS IN A DRY AND WELL-VENTILATED PLACE. CONTAINERS WHICH ARE OPENED MUST BE CAREFULLY RESEALED AND KEPT UPRIGHT TO PREVENT LEAKAGE. STORE IN COOL, DRY PLACE. LIGHT SENSITIVE. RECOMMENDED STORAGE TEMPERATURE: 2 – 8 °C.

ENGINEERING CONTROLS

SAFETY SHOWER AND EYE BATH. MECHANICAL EXHAUST REQUIRED.

PERSONAL PROTECTIVE EQUIPMENT

RESPIRATORY: USE A FULL-FACE RESPIRATOR WITH MULTI-PURPOSE COMBINATION (US) OR TYPE ABEK (EN 14387) RESPIRATOR CARTRIDGES AS A BACKUP TO ENGINEERING CONTROLS. IF THE RESPIRATOR IS THE SOLE MEANS OF PROTECTION, USE A FULL-FACE SUPPLIED AIR RESPIRATOR. USE RESPIRATORS AND COMPONENTS TESTED AND APPROVED UNDER APPROPRIATE GOVERNMENT STANDARDS SUCH AS NIOSH (US) OR CEN (EU).

HAND: PROTECTIVE GLOVES. GLOVES MUST BE INSPECTED PRIOR TO USE.
